For candidates and committees who file with their local election officials

Candidates and committees on the local level, such as school committee and town select board, file reports with their local election officials (such as town clerks).

Occasionally a report is filed, and then weeks or months later, an error is discovered. The form needs to be amended.

This illustrated guide demonstrates how to amend a paper M102 form.
