- 1. Please notify your candidates (by mail or e-mail) that a report is due.
- 2. In the notice, please include the reporting period. The pre-election reporting period is Jan. 1 through 18 days before the election.
- 3. The pre-election report is due eight days prior to the election.
- 4. The post-election report is due 30 days after the election. The post-election reporting period is 17 days before the election until 20 days afterward.
