

THE PROPER WAY TO REFUND A CONTRIBUTOR IS FOR A CANDIDATE OR COMMITTEE TO WRITE A CHECK TO THE DONOR TO RETURN THE FUNDS.

HOWEVER, CONTRIBUTORS SOMETIMES DONATE BY CREDIT OR DEBIT CARD, THEN ASK THE MERCHANT PROVIDER TO RETURN THE FUNDS, BYPASSING THE DEPOSITORY REPORTING SYSTEM.

TO PROVIDE PUBLIC DISCLOSURE, OCPF HAS CREATED A TOOL FOR REPORTING SUCH REFUNDS.

THIS ILLUSTRATED GUIDE SHOWS HOW TO DISCLOSE MERCHANT PROVIDER REFUNDS. MERCHANT PROVIDERS, SUCH AS ACTBLUE, WINRED AND PAYPAL, ARE USED BY CANDIDATES AND COMMITTEES TO COLLECT CREDIT AND DEBIT CARD CONTRIBUTIONS.

IF A CANDIDATE OR COMMITTEE RECEIVES CONTRIBUTIONS VIA THEIR MERCHANT PROVIDER, AND THE MERCHANT PROVIDER INFORMS THE COMMITTEE THAT MONEY WAS WITHHELD TO COVER A REFUND, THE FIRST STEP IS TO DEPOSIT THE NEW FUNDS AT THE BANK AND SIGN INTO REPORT 7.

#### THE PROCESS, IN REVIEW:

AN INDIVIDUAL CONTRIBUTES TO THE CAMPAIGN BY CREDIT/DEBIT CARD USING MERCHANT PROVIDER X.

THE CAMPAIGN DEPOSITS THE MONEY AND FILES A DEPOSIT REPORT WITH OCPF.

THE CONTRIBUTOR ASKS MERCHANT PROVIDER X FOR A REFUND, AND RECEIVES IT.

FUTURE CONTRIBUTORS DONATE TO THE CAMPAIGN USING MERCHANT PROVIDER X. TO RECOVER THEIR LOSS, MERCHANT PROVIDER X WITHHOLDS MONEY FROM THOSE FUTURE DONORS.

THE CAMPAIGN DEPOSITS THE NEW MONEY FROM MERCHANT PROVIDER X, MINUS THE WITHHELD FUNDS, AND CREATES A DEPOSIT REPORT, AS IT NORMALLY WOULD.

THE CAMPAIGN WOULD USE THE "CC CONTRIBUTIONS REFUND" TOOL TO FIND THE DONOR WHO WAS REFUNDED BY MERCHANT PROVIDER X, AND "ADD" THE REFUNDED AMOUNT TO THE DEPOSIT REPORT.

THE CAMPAIGN WOULD ADD THE REFUNDED MERCHANT PROVIDER FEE TO THE SUMMARY PAGE OF THE DEPOSIT REPORT AND E-FILE THE REPORT.
