THE 2022 BALLOT

The state election ballot will be finalized soon for candidates, triggering a few steps at OCPF.

1. OCPF will ensure that all candidates on the ballot have organized a committee or are registered with our agency.
2. OCPF will create specific disclosure pages for House and Senate candidates, sorted by each contest.
3. Our statewide candidate charts will be updated to reflect only candidates who will appear on the 2022 primary and general election ballots.


