INTRODUCTION

This report examines campaign finance activity undertaken by candidates for the Massachusetts Senate in 1992. It is the second time the Office of Campaign and Political Finance has issued such a report.

The Office of Campaign and Political Finance was established in 1973 to administer and enforce M.G.L. Chapter 55 (the Massachusetts Campaign Finance Law), which provides disclosure and regulation of campaign finance activity on the state, county and municipal levels. Based on the purpose for which they were organized, political committees are categorized as follows:

- (1) political committees organized on behalf of an individual candidate for public office in Massachusetts;
- (2) political committees promoting or opposing ballot questions;
- (3) political committees registered on behalf of political parties (ward, town, city and state committees); and
- (4) multi-candidate political committees (so-called PACs).

SCOPE

The statistical information contained in this report is based on information received by the office in campaign finance reports filed by candidates or treasurers of political committees organized on the behalf of candidates for the Massachusetts Senate in 1992. This information does not take into account any corrections, additions or deletions which will occur as a result of audits conducted by the office.

Under section 18 of Chapter 55, campaign finance reports are required to be filed by candidates and/or their committees in order to provide disclosure of their campaign finance activity. Senate candidates and/or their committees are required to file reports once during a non-election year and three times during an election season. The campaign finance law requires that those reports be filed with OCPF eight days prior to the primary election, eight days prior to the general election, and a year-end report on January 10.

On those reports, candidates and/or treasurers are required to disclose their account balance at the beginning of a reporting period; aggregate receipts for a reporting period; aggregate expenditures for a reporting period; in-kind contributions for a reporting period; itemized receipts over \$50; itemized expenditures of \$25 or more; and all liabilities until they are satisfied.

FINDINGS

This report lists the beginning balances, total receipts, total expenditures and in-kind contributions for the 111 candidates for state Senate in 1992. Details of these figures are broken down by seat on the attached pages. Some highlights from the findings of the attached report include:

-- The cost of campaigning for state Senate in 1992 rose as compared to 1990. Only five more candidates ran for Senate in 1992 than in 1990, but total receipts of those candidates were up 20 percent over those of their 1990 counterparts. Similarly, total expenditures of candidates were up 17 percent over 1990. The average total receipts in 1992 increased by 16 percent over 1990, while the average total expenditures increased by 13 percent. (Page 4)

-- Candidates actually had more cash on hand at the beginning of their races in 1990. The total of beginning balances in 1992 decreased by 14 percent from 1990. But given the greater amounts raised by candidates, the total monies available to them in 1992 increased by 10 percent over 1990. (Page 4)

-- While Democratic candidates as a group continue to raise more and spend more in total than Republicans, Republicans in 1992 averaged higher amounts of receipts and expenditures. Democrats raised more total monies than Republicans by an almost 3 to 1 margin, and outspent Republicans by a nearly 2 to 1 margin. However, the Republicans reversed their standing from the 1990 election cycle with regard to average receipts and expenditures per candidate. In 1990, the average Republican candidate raised \$29,907 and spent \$32,524. In 1992, however, those averages rose, to \$53,345 for receipts and \$59,902 for expenditures, reversing the per candidate average advantage the Democrats held in 1990. The 1992 averages for the Republicans represented receipts which were 3 percent higher than their Democrat counterparts and expenditures which were 9 percent higher. (Page 5)

-- For the first time the office broke down the spending by candidates for open Senate seats and those incumbent candidates who ran uncontested. The examination found that the 31 non-incumbent candidates who ran for open seats spent most of their money on advertising (24 percent) and printing and mailing (32 percent). By contrast, nine incumbents not facing opposition still spent an average of \$58,404, but most of their money was spent on fundraising (18 percent) and entertainment and travel (13 percent). Both groups spent roughly the same amounts on office expenses, but incumbents facing no opposition spent far more on political contributions (4 percent) and charitable contributions (9 percent) than non-incumbents seeking open seats (0 percent and 2 percent, respectively). -- For the most part, the candidates who raised the most money were successful in winning Senate seats. The 40 successful candidates raised an average of \$85,900 in 1992, and spent an average of \$92,339 in that same time period. Out of 31 contested races, the candidates who spent the most money were successful in 25 of the races. (Page 7)

-- The most expensive Senate race was in the Bristol and Plymouth district, where four candidates spent a total of \$400,074 during 1992. The least expensive contested campaign took place in the Franklin and Hampshire district, where a total of \$22,195 was spent by two candidates. (In fact, one candidate spent all of the \$22,195, while the second candidate received only \$30 in in-kind contributions and spent nothing.) The least expensive contested campaign in which all candidates spent money was in the Plymouth district, where two candidates spent a total of \$45,132.

-- The most money spent in an uncontested race was in the First Bristol district, where incumbent Sen. Thomas C. Norton spent a total of \$131,145 during 1992. The least money spent in an uncontested race was in the Fifth Middlesex district, where incumbent Sen. Lucile Hicks spent \$12,785 during 1992.

-- The report also lists the 10 Senate candidates who raised the most money in 1992, as well as the 10 Senate candidates who spent the most money in 1992. (Page 6)

-- Election to office appears much easier when candidates come into the election season with significant balances. The 33 incumbent candidates began 1992 with more than 12 times the amount of cash on hand than the 78 non-incumbents. Put another way, incumbents had on average 29 times the amount of cash on hand than non-incumbents at the beginning of 1992. In 25 of those 33 races, the incumbents won. (Page 13)

Considerable effort has been made to insure the accuracy of the data contained in this report. However, for numerous reasons, the detailed information may contain errors. In addition, none of the data is adjusted for inflation.
